Kobe city Accommodation Subsidy Program

1 Outline

Kobe Tourism Bureau offers a Subsidy (50,000 yen per group. Maximum of 4 groups, 200,000 yen) to travel agencies that sends group tours (More than 20 pax per group) staying in Kobe.

2 Period

April 1, 2023 to March 31, 2024.

- * The date of the group to stay in Kobe. * If the budget is completed, this program will be terminated without notice.
- * The program will be continued in the next fiscal year, but the content and conditions are subject to change.

3 Qualified Business Operators

Travel agencies and land operators handling group tours to Japan.

* NOTE: Subsidy cannot be transferred overseas.

Applications can be submitted by overseas operators, but the bank account to which subsidies are transferred must be in Japan.

If you do not have an account in Japan, you may receive the subsidy through your business partner in Japan.

4 Terms & Conditions

Tour groups that meet the following conditions.

- 1) More than 20 pax (excluding TL, TG).
- 3) Visiting to at least 1 tourist facility in Kobe.
- 2) Staying at least 1 night in Kobe city.
- 4) Having Lunch or Dinner in Kobe

5 Application Methods

- 1) Application form must be submitted **by 14 days prior** to staying.
- Please send (1) Application Form (2) Itinerary (3) Company Profile by e-mail to the application office.
- After receiving your application, it takes about 1 week for approval.
- 2) 1 agent can apply for this subsidy program at maximum of 4 times in a fiscal year.
- * It is not allowed to use other subsidy programs by the Kobe city
- 3) Please submit the final itinerary and certificate of accommodation (issued by the hotel) to us within one month after the tour. Payment will be made upon confirmation.
